# **Privacy Policy**

Policy on the collection, use and disclosure of personal information.

Royal LePage Binder Real Estate reserves the right to decline access to Personal Information where the information requested:

- a) Would disclose the Personal Information of another individual or of a deceased individual;
- b) Would disclose business confidential information that may harm Royal LePage Binder Real Estate or the competitive position of a third party;
- c) Is subject to solicitor-client or litigation privilege;
- d) Could reasonably result in: (i) serious harm to the treatment or recovery of the individual concerned; (ii) serious emotional harm to the individual or another individual; or (iii) serious bodily harm to another individual;
- e) May harm, or interfere with, law enforcement activities and other investigative or regulatory functions of a body authorized by statute to perform such functions;
- f) Is not readily retrievable and the burden or cost of providing would be disproportionate to the nature or value of the information; or
- g) Does not exist, is not held, or cannot be found by Royal LePage Binder Real Estate.

Where information will not or cannot be disclosed, the individual making the request will be provided with the reasons for non-disclosure.

Where information will be disclosed, Royal LePage Binder Real Estate will endeavor to provide the information in question within a reasonable time and no later than 30 days following the request.

Royal LePage Binder Real Estate will not respond to repetitious or vexatious requests for access. In determining whether a request is repetitious or vexatious, it will consider such factors as the frequency with which information is amended, the purpose for which the information is used, and the nature of the information.

### 1. OBJECTIVE & SCOPE OF POLICY

This office only collects personal information necessary to effectively market and sell the property of sellers; to locate, assess and qualify properties for buyers and to otherwise provide professional and competent real estate services to clients.

Royal LePage Binder Real Estate, Brokers or Sales Representatives may use personal information for commission management purposes (e.g. commission financing, commission dispute resolution); personal promotion and marketing of Independent Brokers & Sales Representatives under contract; and assembling relevant information for market evaluations (CMA) for potential sellers/buyers.

Royal LePage Binder Real Estate's use of Personal Information is limited to these purposes. Royal LePage Binder Real Estate does not sell, trade, barter or exchange for consideration any Personal Information it has obtained. Unless permitted by law, no personal information is collected about an individual without first obtaining the consent of the individual to the collection, use and dissemination of that information.

Personal Information will be collected, to the extent possible, directly from the individual concerned.

Royal LePage Binder Real Estate does not knowingly collect Personal Information from anyone under the age of 18, especially children under 13, and does not use such information if Royal LePage Binder Real Estate discovers that it has been provided by a minor.

- Where the information is public.

Where obliged or permitted to disclose information without consent, Royal LePage Binder Real Estate will not disclose more information than is required.

### 3. ACCURACY

Royal LePage Binder Real Estate endeavors to ensure that any Personal Information provided by Clients and in its possession is as accurate, current and complete as necessary for the purposes for which Royal LePage Binder Real Estate uses that data. Information contained in files that have been closed is not actively updated or maintained.

### 4. RETENTION

Royal LePage Binder Real Estate retains Personal Information as long as Royal LePage Binder Real Estate believes it is necessary to fulfill the purpose for which it was collected and Firm legal or business requirements.

### 5. SECURITY

Royal LePage Binder Real Estate endeavors to maintain adequate physical, procedural and technical security with respect to its offices and information storage facilities so as to prevent any loss, misuse, unauthorized access, disclosure, or modification of Personal Information.

### **6. ACCESS TO PERSONAL INFORMATION**
